



## **CBAACONVENTION DELEGATE TERMS AND CONDITIONS**

### **1. DELEGATE REGISTRATION CANCELLATION AND CONTINGENCIES**

- Delegates may cancel their registration in writing to [membersupport@cbaa.ca](mailto:membersupport@cbaa.ca), and receive a full refund until thirty (30) days prior to the convention, less an administration fee of \$50.00. No refunds will be issued for cancellations received less than thirty (30) days prior to the convention.
- Delegates who cannot attend may send an alternate individual from the same organization. Substitutions will be accepted until fifteen (15) days prior to the convention.

### **2. BADGE PICKUP AND BADGE SHARING**

- Badges must be picked up by the attendee themselves; other attendees cannot collect badges on someone else's behalf.
- Attendees with Tradeshow Exhibit Only badges can pick them up at the registration booth on Thursday morning.
- Badge sharing is **strictly prohibited**. Attendees are required to wear their own badge at all times during the convention.

### **3. PHOTOGRAPHY/VIDEOGRAPHY DISCLOSURE**

- For promotional purposes, photographic and video recordings may be taken during the convention. As a registered attendee of the CBAACONVENTION, you agree to grant permission for CBAACONVENTION to use your likeness in a photograph or video in any and all of its publications and presentations, including website entries, without payment or any other consideration; to authorize CBAACONVENTION to alter, copy, exhibit, publish or distribute the photograph or video for purposes of publicizing future CBAACONVENTION programs or for any other lawful purpose; to waive the right to inspect or approve the finished product, including written or electronic copy, wherein your likeness appears; and that these materials will become the property of CBAACONVENTION. **Registrants who do not wish to be filmed or recorded should advise CBAACONVENTION in writing prior to the convention by emailing [membersupport@cbaa.ca](mailto:membersupport@cbaa.ca).**
- CBAACONVENTION shall not be liable for any Exhibitor's use of a photo/screenshot/video containing Registrants' images or for Exhibitor's failure to obtain consent from Registrants.
